ABOUT JAL MEHTA, PH.D. Jal Mehta is an associate professor at the Harvard Graduate School of Education. His research explores the role of different forms of knowledge in tackling major social and political problems, particularly problems of human improvement. He has also written extensively on what it would take to improve American education, with a particular focus on the professionalization of teaching. His most recent book, *In Search of Deeper Learning*, is a contemporary study of schools, systems, and nations that are seeking to produce ambitious instruction.
